Minutes from Nov 7, 2023

Meeting was called to order by President Phyllis Renninger at 6:39 PM.

Treasurer's Report: The Studio Tour net profit was \$15,000. Our bank total is currently about \$36,000 and \$10,000 was moved to a money market account.
